**8. HEARING OF CITIZENS - Topics to include those items not listed in the agenda.**

Citizen Phil Young addressed the Council with concerns about a gun being shot off out at Falcon Lake. A week ago Saturday there was a shooting incident out at Falcon Lake. Neighbors shot assault weapon 49 times in the direction of his home. Mr. Young's grandchildren were playing in the yard at the time. He had a few questions that were not addressed on the police report. He felt there was missing information on the police report.

Man had 2 loaded weapons in his car – no charge for transporting loaded weapons.

Man had his girlfriend with him – Second party was not charged

Police report does not address if he had an assault weapon permit. If he did maybe he is allowed to transport a loaded AK47 and loaded 223 assault weapon. His understanding of the law is that weapons are to be transported unloaded and outside the vehicle.

Only charge man got was wreckless endangerment. He was arrested but this charge will get him discharged quickly. Also, does the property owner have any responsibility for this situation? Do not think this person got charged enough, another house received damage.

Mayor Valerie Thomerson asked for Mr. Young's phone number so he can be contacted by the Police Chief for follow up. Councilman Donnie Robinson asked for additional follow up as well. City Manager Jim Crosby explained that he will make sure additional follow up is provided to the entire Council.

Citizen Jodi Gross of 5717 N. Ridge – spoke about the roads near her home. They are in terrible condition and are becoming dangerous.

Community Development Director Wade Harden explained that all ponds and dams are inspected by an engineer. Anytime there is earth moving equipment involved then a fee is charged. Important to make sure an engineer looks at the pond to prevent flooding.

Mayor Valerie Thomerson explained that conversation was too extensive and item will need to come back to Council as an agenda item.

Councilman Robert Simpson asked for item to come back before City Council so he can have a better understanding of the fee.

Councilman Bobby Williamson – Thank you to Bud and his crew. He runs into them a lot during the day, they are always out working. Feel good about spending money on the roads. Would like a workshop with an outline of plans for future road repairs.

Mayor Valerie Thomerson – she commented that she has gone back to work full-time Downtown and needs some assistance with the cities ACOG responsibilities. Councilman Donnie Robinson offered to assist. Also commented that she received a call from Abby Wilson, would like Arrowhead Rd. @ Sara and Morgan looked at. The road has become so bad they have to drive off of the road.
